MAY 2nd, 2023 MINUTES REGULAR MEETING

Mayor Bedford called the meeting to order at 7:29 pm with Deputy Mayor John Cairns, Councillor Brad Brown, George Cyr, Jeanette Spearing, Shawn Brown, and Gregory Moran present. Also present was CAO Brian Baker.

Approval of Agenda

A Motion was made by Councillor Shawn Brown, seconded by Councillor Moran and unanimously to approve the May 2nd, 2023 agenda.

Delegations:

<u>Peter DeSotta, Bay Baie</u>: Mr. DeSotta expressed his concern regarding the number of vehicles that are speeding in St. Martins. He has requested that the council consider installing speed bumps and a bike lane for bicycles.

Byard Moran, Century Farm Campground: Mr. Moran expressed his concern regarding a dirt bike that has been travelling on Main Street on one wheel. He is concerned for the safety of the driver. He would also like to have speed bumps installed on Main Street and a traffic control sign as he feels that the trucks are going too fast. He also mentioned that when the Fundy Trail Parkway was initially discussed, it was to have a wilderness campground only.

Sgt. Nelson, RCMP: Sgt. Nelson mentioned that he had a conversation with the driver of the dirt bike that Mr. Moran was concerned about. Sgt Nelson updated the council that there is a new RCMP officer living in Willow Grove. There were 30 files in Willow Grove, 6 files in Baxter Corner, 4 files in Rowley, 1 file in West Quaco, 12 files in Bains Corner and 7 files in St. Martins.

Envision Saint John: Envision Saint John did a presentation to the Council giving a description of the mandates that they are responsible for. They have a strategic plan that they shared with the council. They are a sponsor of the Sea Shanty Festival. When asked about funding a web page for Fundy-St. Martins, they mentioned that they are unable to provide funding but could supply names of companies that could help with creating a web page.

New Business:

Commissions & Committees:

- 1) Financial Mayor Bedford reported that a meeting was held in Fredericton with Gary Crossman, MLA, Tammy Scott-Wallace, Minister of Tourism and Daniel Allain, Minister of Local Governance. The financial state of Fundy-St. Martins was discussed. The need for a new soccer field and summer students for the VIC was discussed.
- 2) <u>Human Resources</u>: Councillor Spearing and Deputy Mayor Cairns reported that they had gone over the first 5 policies and were going to look at the next 5. The next meeting is May 17.
- 3) <u>Administration By-Laws</u> Councillor Spearing and Deputy Mayor Cairns reported that the next By-Laws that they would be looking at are littering, ATV and parking overnight.
- 4) <u>Communications & Active Living</u> Councillor Shawn Brown: The website for Fundy-St. Martins is being worked on. There were 14 entries submitted for the Logo contest.
- 5) <u>Special Projects</u> Greg Moran and Brad Brown: The tender to have the work completed at the VIC has closed and the Special Projects will be meeting to make recommendations as to who to award the contract to. The tender for the Consultants design work is ready to be released.
- 6) <u>Emergency Management & Public Safety</u> Jim Bedford and George Cyr: The committee has 10 members, and the executive Director is Grant Grills.

<u>Update on work being completed at Tourist Information Bureau:</u> The tender has closed and the Special Projects committee will be meeting to make recommendations to the Council as to who should be awarded the project. The tender for the Consultants Design Work is ready to be put out for Tender.

<u>Discussion on Canada Heritage Grant:</u> Clerk Jean McCumber updated the Council that she had applied for \$10,000 but was notified that Fundy-St. Martins had received \$3000.00. The recommendation is that Council purchase flags for the Hydro polies. Councillor Shawn Brown recommended that this decision be put off until the next meeting of May 9. It was recommended that CAO Baker contact Tammy Scott-Wallace office to enquire about receiving funding for additional brackets that could be installed in Simonds.

Transfer Canada Community Building Fund money from General Account to CCBF Account: A motion was made by Councillor Shawn Brown to transfer \$ 19,884.00 from the General Operating Account to the Gas Tax Account. These are top up funds that was owed to the Village of St. martins from the Canada Community Building Fund for 2022. This motion was seconded by Councillor Moran and passed unanimously.

Councillor Shawn Brown made a motion to have the 3rd Reading of the Tourism Accommodation levy By-Law. This was done by reading the title. The Tourism Accommodation Levy By-law seconded by Deputy Mayor Cairns and passed unanimously.
